About This Role

The City of Mountain View is seeking **highly qualified professionals** to fill two vacancies for the position of Fire Protection Engineer (FPE). The Fire Protection Engineers will be Fire Department employees but will be located in the Building Inspection Division under the supervision of the Chief Building Official. These are civilian positions which will be part of the Community Development Department's Development Services Center. These positions are responsible for the review of site and building plans; fire suppression and alarm systems; and support specifications for buildings and building modifications to ensure compliance with Federal, State, County and local fire safety ordinances, laws and codes. Duties will also include field inspections of construction sites, review of site and building development plans for local fire protection and system requirements, Fire Department equipment access, and other related responsibilities. The Fire Protection Engineers provide technical advice to City staff, contractors, architects, developers and the general public. - Review plans and specifications of proposed buildings and building modifications for adherence to Federal, State and local fire safety ordinances, laws and codes.
- Review plans and specifications for, and performs inspections and acceptance tests on fire protection systems, such as heat and smoke detection systems, fire alarms systems, fire sprinkler systems and special hazard protection.
- Review site development plans for proposed or existing buildings to ensure adequate water supplies, water distribution systems, fire hydrant availability and Fire Department equipment access.
- Review plans for compliance with fire and life safety requirements in accordance with Titles 19 and 24 of the California Administrative Code.
- Conduct fire safety inspections of buildings, structures, premises and installations to enforce compliance with Federal, State and local fire safety laws, codes and regulations.
- Coordinate plan reviews with field inspection activities to ensure the provisions of all applicable State and local fire safety laws, codes and regulations are enforced.
- Provide technical advice to City staff, architects, engineers, developers, building owners, the Fire Chief, City
 commissions and boards, and the general public on the interpretation or application of fire safety codes and
 regulations.
- Conduct special studies regarding fire hazards, fire response systems and other related fire protection services and
 makes recommendations for improving the City's fire protection services and its role in the development review
 process.
- Work proactively with other City staff and departments to maintain, implement and coordinate the City's development review process.
