- Directs review of private development plans to ensure conformance with the municipal code.
- Supervises engineering staff in planning, design, construction and administration of the Capital Improvement Plan.
- Plans, programs and schedules engineering and support personnel on assigned projects and programs.
- Reviews and signs parcel and subdivision maps and development plans for conformance with the Subdivision Map Act, City standards and municipal code.
- Serves as the Acting Public Works Director in his or her absence.
- Interprets City code and policies related to City infrastructure and private development.
 Establishes City engineering standards. Enforces City Engineering and Public Works
 Department designated duties of the Belmont Municipal Code.
- Serves as Program Manager for various infrastructure related funds.
- Oversees compliance with regulatory requirements to include the State Water Resources Control Board permits for the stormwater and sanitary sewer systems.

The Department

The Belmont Public Works Department keeps the city running by managing essential infrastructure, from streets and traffic to sewer and storm drains, solid waste, fleet services, and engineering projects. With a \$26.6 million budget and 33 dedicated staff, the department also oversees a \$25.4 million Capital Improvement Program (CIP), tackling major upgrades in traffic, streets, drainage, parks, and city facilities. The Engineering Division leads capital projects, regulatory compliance, and grant funding while aligning with City Council priorities. Meanwhile, Field Operations maintains 70 miles of streets, 85 miles of sewer lines, 27 miles of storm drains, 15 signalized intersections, and the city's 71-vehicle fleet.



Public Works recently received its American Public Works Association accreditation, reinforcing its commitment to safety, efficiency, and innovation. As a key player in Belmont's growth, the department supports major development initiatives, including housing expansions, life science campuses, and recreational projects in partnership with Parks & Rec.

The City of Belmont offers a comprehensive range of benefits that are designed to support your professional growth, personal well-being, and overall job satisfaction. Here is a summary of the benefits you can expect to receive:

Health Insurance - You will have access to comprehensive health insurance plans, which include:

- Medical insurance via the <u>CalPERS Medical Program</u>. With a City contribution of up to \$2,893.54 a month towards plan premium.
- Employer paid dental insurance via Delta Dental PPO (nominal monthly cost for dependents).
- Vison Insurance via VSP for you and your eligible dependents.

Retirement- The City of Belmont participates in the <u>CalPERS Retirement Plan</u>. Employees are enrolled at the <u>PEPRA Member</u> or <u>Classic Member</u> subject to <u>CalPERS regulations</u>.

Retirement Health Savings Account - The City makes a monthly contribution to employee's account based on years of service from \$150.00 - \$300.00 per month. Vested after ten (10) years of continuous service.

Deferred Compensation - The City makes a monthly contribution of \$335.00 per month into employee's <u>457 Deferred Compensation Account</u>. In addition, employees can make pre-tax contributions via payroll deduction.

Paid Time Off: We understand the importance of work-life harmony. You will receive accrual of paid time off, including vacation days, sick days, and holidays.

- Vacation Accrual starts at 6.33 hours per month of service, equal to ten (10) days per year. Prior years of public service may be considered when granting accrual rate.
- Administrative Leave 80 hours per year.
- Sick Leave Earned at one day (8 hours) per month of service.
- Eleven (11) Holidays with two (2) Floating Holidays after a year of service


