# Benefits Summary

## Retirement

Employees are covered by the California Public Employees' Retirement System (CALPERS). The formula used is 2% at 60 for employees new to CALPERS, hired on or after January 1, 2013; and 2.7% at 55 for classic CALPERS members. The city pays the employer portion of CALPERS. Employees pay 100% of the employee's share of the CALPERS retirement contribution. The city does not participate in Social Security, except for the mandatory Medicare Program.

## Deferred Compensation

The City offers a 457 deferred compensation program through ICMA. Each employee may defer up to the maximum allowed by the IRS.

## Flexible Spending Account

The City offers a Flexible Spending Account which allows employees to set aside pre-tax dollars to pay for eligible health insurance premiums, healthcare expenses and/or childcare.

## Life Insurance

The City provides \$50,000.00 of term life insurance for regular, full-time employees.

## Sick/Vacation Leave

An employee accrues four hours of sick leave per pay period. There is no limit on the amount of sick leave accrual. 80 hours of vacation are earned per year, increasing to 120 hours after four years of employment and 160 hours after five years of employment. Vacation hours are accrued pro-rated per pay period.

## Holidays

There are 13.5 paid holidays per year.

## Education Reimbursement

Employees may request up to \$1,000 per fiscal year for expenses incurred for tuition, books and fees for college-level or job-related courses or degree curricula upon prior approval.

## Medical, Dental and Vision Insurance

The city provides a monthly allocation of \$1,500.00, up to \$1,702.32, which may be applied towards the cost of benefits made available by the city at the option of the employee.

Medical insurance is available through CALPERS for employee and eligible dependents.

Dental and Vision Insurance is available for employee and eligible dependents.
