The ideal candidate is confident conducting risk assessments suicide, homicide, and grave disability evaluations—and is knowledgeable about legal standards, including Welfare & Institutions Code 5150 procedures. The ideal candidate is a natural collaborator who works effectively alongside law enforcement, community partners, and service providers to ensure individuals receive the least restrictive, most appropriate intervention and are safely connected to the appropriate resources.

- 2. Obtain full licensure within timelines consistent with the California Welfare & Institutions Code and relevant licensing board. Progress toward licensure will be reviewed periodically to ensure compliance.
