The Department consists of the Chief of Police, two Sergeants, and five Officers. The Officers work a 3/12 – 4/12 hour schedule and handle calls for service enforcing local and state law. Our Officers partner with other Town departments and other local law enforcement to provide excellent service to our community. Officers respond and investigate crime, manage traffic, as well as problem solve quality of life issues in Town. Our officers are well equipped and trained. Officers are assigned to a patrol shift, under the supervision of a sergeant. Officer shifts rotate at least yearly.
