# Public Works Inspector

## An Outstanding Opportunity

The City of Lafayette (pop. 24,000) is recruiting for the position of an Public Works Inspector. Lafayette prides itself on its vibrant downtown, beautiful tree-studded hillsides and great schools. Lafayette residents expect personalized service to deliver customized solutions to the community's unique engineering and public works priorities. This position will be part of the team whose mission is to meet that challenge, and to ensure that Lafayette retains its semi-rural character and "small town" downtown feel.

Position will primarily provide inspection services for encroachment permits, perform "clean water" inspections, send code enforcement letters with follow-up inspections, and support City maintenance projects. The inspector will spend a significant portion of time in the field.

This is a challenging job in a great city! The new Inspector will be joining a staff of dedicated, energetic and fun professionals.

## The Position

The Public Works Inspector is part of the Engineering Services Department and performs the following major duties:

- ◆ Inspects public works projects for conformance with plans, specifications, contract provisions and safe work practices.
- ◆ Assists with encroachment permit and transportation permit programs.
- ◆ Performs engineering surveys.
- ◆ Monitors and performs field tests for quality assurance, including soil compaction, concrete compliance.
- ◆ Acts a liaison between the City, contractors, other agencies, businesses and residents affected by projects.
- ◆ Performs field investigations of problems affecting property owners, contractors, and maintenance operations and responds to citizen inquiries and complaints.
- ◆ Performs light maintenance tasks as required such as signal timing and operation.
- ◆ Writes reports and prepares sketches of issues found in field inspections for review and development of solutions by senior engineering staff.



## The Ideal Candidate

The ideal candidate will have familiarity with principles, procedures, methods, materials and techniques used in public works projects including appropriate safety practices. Qualified candidates should have the ability to communicate effectively with the public and possess field inspection experience. Equivalent of a high school diploma supplemented by college level coursework or training in engineering or a related field plus two years of public agency experience in public works infrastructure construction, inspection or similar experience is a typical way to obtain the required qualifications.



## Compensation & Benefits

The salary range for the position is \$74,414 — \$97,883. Lafayette also provides an attractive benefits package that includes:

- ◆ A 401-A retirement plan with City-paid monthly contributions of 10% of salary with the option of a 5% match as well as City-paid social security contributions. **Lafayette does not participate in PERS.**
- ◆ City-subsidized health and dental insurance as well as life insurance and disability insurance.
- ◆ 12 paid holidays and up to 20 days of annual vacation, depending on tenure.
- ◆ Challenging, interesting work; opportunities for innovation and creativity; family friendly policies; and casual dress.
