This position, under the general supervision of the Director, the cook is responsible for the preparation of food, for maintaining high standards of food quality, food production and portion control using standardized recipes; may be responsible for ordering appropriate quantities to meet menu requirements; ordering supplies, and maintaining perpetual and physical inventory. This position is full-time, and is scheduled for forty (40) hours per week.

This candidate will be have the knowledge of the methods used for food preparation and cooking techniques for a large number of people. Know the Health and Safety Code requirements for handling and preparation of food. Ability to use utensils, containers, and equipment used in preparing food. Be skilled in the safety and sanitary consideration relevant to cooking and serving food.

- Cleans and sanitizes kitchen, serving areas, storage facilities, refrigerator/freezer, cooking equipment utensils, cookware, and assists in maintaining kitchen equipment.

- Coordination of kitchen and dining area clean up in accordance with site sanitary standards.
- Performs all duties in accordance with applicable federal, state, and county rules, regulations and established standards of quality and sanitation.
