A. PURPOSE:

Under supervision, ensures enjoyable experience for park visitors and recreational facility users by providing clean, well-maintained, and attractive parks and facilities and information about park and recreation facilities and services.

B. <u>DISTINGUISHING CHARACTERISTICS:</u>

Some positions may require a valid Commercial Applicator's Certificate, and involve the use of mechanized spraying equipment for the application of pesticides and herbicides. This class is further distinguished by need for greater independence of judgment and action and because incumbents may act as a lead worker with other Park Workers.

C. ESSENTIAL FUNCTIONS:

Maintains hazard-free, attractive park and recreational facility by:

- 1.) Mowing, watering, and shaping lawns and shrubs.
- 2.) Planting, watering, cultivating, weeding, pruning, and fertilizing trees, shrubbery, flowers, and lawns at City parks and recreational facilities.
- 3.) Emptying trash receptacles, mopping, sweeping, and raking park sites as needed.
- 4.) Performing semi-skilled plumbing, carpentry, painting, and mechanical maintenance of recreation equipment and facilities.
- 5.) Maintaining and repairing playground equipment.
- 6.) Hauling debris from park sites to landfill area.
- 7.) Installing and replacing bullards and fences.
- 8.) Assembling tables, benches, and bleachers.
- 9.) Rototilling, grading, and smoothing infields at ball diamonds.
- 10.) Maintaining tennis courts, including replacing of nets and lights.
- 11.) Installing, maintaining, and repairing sprinkler systems in City parks.
- 12.) Performing related work as required.

D. **ESSENTIAL RESPONSIBILITIES**:

- 1. General and Specialized Job Knowledge and Abilities:
 - (a) <u>General Knowledge of:</u> Basic methods, materials, and equipment used in the care of maintenance of parks, grounds, and recreation facilities.
 - (b) Specialized Knowledge of: Tools used in the construction and maintenance of parks, landscaped area, operate and maintain chemical spraying equipment in performance of chemical spraying duties, operate hand tools mechanical equipment in a safe and effective manner.
 - (c) <u>Ability to:</u> understand and follow oral and written instructions. Ability to perform physical work requiring manual labor and dexterity. To establish and maintain effective work relationships with co-workers and general public.
- 2. Resources, Including Money, Equipment, Materials and Records:

 Various hand and power tools, digging and cutting tools, portable generator, telephone, reports, form, pencils, and pens, calculators, automobile, two-way radio, pager, maps, plans, and blueprints, key to City locks.

In addition, some positions may require a valid Commercial Applicator's Certificate, and involve the use of mechanized spraying equipment for the application of pesticides and herbicides. This class is further distinguished by need for greater independence of judgment and action and because incumbents may act as a lead worker with other Park Workers.

C. <u>ESSENTIAL FUNCTIONS:</u>

- 1.) Provides for well-maintained, hazard-free, attractive park and recreational facility setting by:
- 2.) Preparing, mixing, and applying toxic chemicals for weed, grass, and/or pest control purposes.
- 3.) Applying soil nutrients to trees, ornamentals, and lawns.
- 4.) Troubleshooting automatic sprinkler system and timers
- 5.) Repairing, replacing, and installing sprinkler valves, controllers, micro-switches, and sprinkler heads.

Performs park maintenance task and oversees, directs and coordinates park worker crews in a lead capacity.

B. <u>DISTINGUISHING CHARACTERISTIC:</u>

This is a lead worker position and is distinguished from the Parks Worker I/II position by responsibility for adhering to schedules and maintaining quality of park projects, productivity of the park's workers and safe operations of equipment.

C. ESSENTIAL FUNCTIONS:

- 1) To perform general parks maintenance duties.
- 2) Oversee, coordinate, and/or lead park district personnel, support services crews and park maintenance crews.
- 3) Work with crew to assure accuracy and compliance to City standards.
- 4) Assist Parks Supervisor in scheduling and directing the work of a crew assigned to the Parks Division.
- 5) Monitor daily logs of work in progress and jobs completed by crews.
- 6) Perform skilled work in the efficient and safe operation of parks maintenance equipment.
- 7) Respond to public complaints regarding parks projects and inform public of City standards and policies.

- 8) Inspect park vehicles and equipment to assure safe operating conditions.
- 9) Assist Parks Supervisor in training new employees in established procedures and safe equipment operations.
- 10) Operate power and hand tools such as blowers, mowers, edger's, sod cutters, aerifiers, and chain saw.
- 11) Maintain and perform complex repairs to sprinkler/irrigation system; install and repairs sprinkler heads, clocks, lines, valves, and controllers; set controllers to regulate watering.
